RE: Inflation Relief Subsidy

TO: All Nation Membership

In the past couple of months, our Nation and its members have been hit hard with the rising costs of energy, food and fuel.

By Order of Council, we will be providing our members a one-time Inflation Relief Subsidy:

LRRCN Members who are 18 years of age and older will receive \$1000.00 per adult. LRRCN Members 17 years of age and under will also receive \$500.00 per child, payable to the parent/legal guardian.

Each adult in a family needs to submit a form but only one parent can receive the subsidy for the children.

The Inflation Relief Subsidy will be issued to all living LRRCN Members as of December 15th, 2022, and will be released on December 15th, 2022, by either cheque or direct deposit.
