




DO HEREBY RESOLVE: ALL PICTURES OR VIDEOS WILL NOT BE POSTED WITHOUT THE EXPRESSED CONSENT OF CHIEF AND COUNCIL AND THE LIMIT OF UNAUTHORIZED ACCESS TO FOX LAKE OF EXTERNAL PARTIES AND UNAUTHORIZED REMOVAL OF HOME OWNER PETS.


- WHEREAS** The undersigned, being the duly elected Council for the Little Red River Cree Nation (the “Nation”) by way of an election of Chief and Councillors (collectively known as “Council”), each of whom has one vote and are empowered to vote on and act upon each Band Council Resolution (“BCR”) passed by simple majority, on behalf of the Nation, and;
- WHEREAS** Council having met in the quorum at a duly convened meeting, and
- WHEREAS** To eliminate direct or indirect trauma for our residents of Fox Lake and to respect their needs and the mental and physical well being;
- WHEREAS** All active personnel working within Fox Lake, AB., and other possible external parties who are not affiliated with Little Red River Cree Nation and or part of the Emergency Response and or Active Firefighting Operations coming into Fox Lake, Alberta will refrain from taking pictures and or videos of the tragedy that the PASKWA fire has left behind;
- WHEREAS** Videos and Pictures used for recovery or cataloguing purposes and or damage assessments are allowed providing that they are not shared to external parties and or shared in any social media platforms and or websites, and or news outlets and;
- WHEREAS** Due to active ground fires and or various hazards caused by the PASKWA fire, Unauthorized access will result in the ban of any external party crossing into our community of Fox Lake;
- WHEREAS** Any unauthorized removal of pets and properties by external parties not affiliated with Little Red River Cree Nation or without the expressed consent of Chief and Council and or our Emergency Management Team will result in immediate removal from all Little Red River Cree Nation grounds and will be banned from entering all Little Red River Cree Nation;


NOW THEREFORE BE IT RESOLVED the Nation strives to protect the lives and limit additional stress and or trauma to all effected from the Paskwa Fire in Fox Lake, Alberta. The safety of lives will always be put first and we will continue to uphold our culture, customs, laws, language and we ask all external parties entering our Little Red River Cree Nation communities of Garden River, AB., John D’or Prairie, AB., and Fox Lake, AB., to respect our people, culture, language, traditional and ancient practices, data and our inherent rights and treaty rights.
